Happy New Year!!!

Are you one who makes New Year resolutions? I really never have, but understand why many people do. Turning the calendar from one year to the next is a natural time for reflection. What all happened in our lives in 2022 and what does 2023 have in store for us? And how might we live differently in the year to come? Might we set new goals and aspirations for the coming year?

One of the special traditions of the Church of South India, which I discovered while our family was living in India is the "Covenant Service". This service took place within worship on New Year's Day. As worshippers stood on the brink of a new year, it was deemed an appropriate time to ponder their life of faith and to renew their covenant with God. Again, we often think of a new year as a time for resolutions. Perhaps we should celebrate every New Year by examining our resolve as people of faith.

As people of faith, we are bound by a covenant. The heart of the covenant found in the Hebrew Scriptures is expressed: "I shall be your God and you shall be my people." In our baptism, we are bound as followers of Jesus Christ as his love and grace is poured over us through the symbol of water. Each time we partake of the sacrament of Holy Communion we remember and renew our covenant with God – as well as with each other. As our United Church of Christ says it, "we are bound in covenant with faithful people of all ages, tongues, and races."

I hope you can join us for worship on New Year's Day. And even if you can't, I hope you take a few moments to reflect on the place of faith in your life. And then resolve to continue serving God as the gift of a new year presents you with daily opportunities to do just that. I would like to conclude this month's reflection with the prayer of commitment that concludes the Church of South India's covenant service.

I am no longer my own, but yours, O God.

Put me to what you will, rank me with whom you will; put me to doing, put me to suffering; let me be employed for you or laid aside for you, exalted for you or brought low for you; let me be full, let me be empty; let me have all things, let me have nothing; I freely and heartily yield all things to your pleasure and disposal.

And now, O glorious and blessed God, Father, Son, and Holy Spirit, you are mine, and I am yours. So be it. And the covenant which I have made on earth, let it be ratified in heaven. Amen.

WERF: Washington Emergency Relief served 75 people in November 2022. This mission provides emergency relief to individuals and families. The office is located in our church. The phone number is 636-239-6633.

The Harvest Table: The Harvest Table is a free and open community meal served every Saturday at St. Peter's UCC from 5-6 p.m. In November, 535 hot meals were served. Over 100 coats were given away; hats, gloves, scarves, and socks were provided to those in need.

Salam Free Clinic: This free medical clinic is held every second Saturday, from 2:30 – 4:30 p.m. at St. Peter's UCC. This clinic is a collaboration of services provided by The Muslim Community of St. Louis (our doctors), Deaconess Nurse Ministry (Nurse Leesa), and St. Peter's UCC (volunteers who assist with registration). Medical services are provided to adults at no cost. We served seven patients in November.

In addition to these ongoing efforts, 5 members passed out 500 Christmas greeting magnets from St. Peter's UCC at the Parade of Lights. Choir members were invited to sing at Mt. Pleasant winery, Homestead and Oak Point care facilities and the Historical Society dinner.

January Book Review

The Justice and Witness Mission Group of St. Peter's continues to offer a small lending library located in the parlor just off the sanctuary through the atrium. The books cover a range of topics including current events, religion, racism, aging, personal growth and LGBTQIA. If you have a desire to learn more about any of these issues, please, borrow a book. The process is simple. Just sign your name on the index card inside the front cover and place it in the file box provided. When you're finished reading, just drop it in the green bin provided. If I Am Missing or Dead begins with a note taped inside a desk drawer. Today Ron Ball and I are romantically involved, it read, but I fear I have placed myself at risk in a variety of ways. Based on his criminal past, writing this out just seems like the smart thing to do. If I am missing or dead this obviously has not protected me...

Ten weeks later, Janine Latus, the author, has left her own abusive marriage and her sister Amy has disappeared. It takes two years to convict the murderer of her sister. Amy died in silent fear and pain. Haunted by this, Janine Latus turned her journalistic eye inward. How, she wondered, did two seemingly well-adjusted, successful women end up in strings of physically or emotionally abusive relationships with men? If I Am Missing or Dead is a heart-wrenching journey of discovery as Janine Latus traces the roots of her own -- and her sister's -- victimization with unflinching candor. This beautifully written memoir will move readers from the first to the last page. At once a confession, a call to break the cycle of abuse, and a deeply felt love letter to her baby sister, Amy Lynne Latus, If I Am Missing or Dead is an unforgettable read.

Highlights of the St. Peter's UCC Dec. 19, 2022 Council Meeting

<u>Treasurer's Report</u>: For a third month in a row a negative General Fund balance of (\$12,506) has occurred. Though we are still hopeful for year's end donations, this is very concerning. Heritage Bank balance is currently \$90,571.

Though our Budgeted Income is down \$112,000 for the year, our yearly expenses are under the projected budget by \$74,486, which is very good.

<u>Finance Board</u>: Outreach and communication needs to be improved and will be addressed. Underwriting of specific expenses and costs to encourage donations and attempts to reach new donors will be expanded.

Pledges are still coming in and we appreciate responses. In recent years donations have been generally divided 85% to General Fund and 15% to Building Fund unless specified. The Finance Board requested that we change that to 90% General Fund and 10% Building fund.

Paying off Heritage Community Bank Loan was discussed. This carries an interest rate of 4.02% and is \$2,000 each month paid out of the Building Fund. The Finance Board analyzed and suggested by paying \$3,000 each month we could reduce interest and pay off earlier. Current balance is \$28,800.

Property Sale Account balance is \$146,652 and gains little/almost no interest currently. It was suggested by the board to place in a CD which could pay approx. 4%.

<u>Harvest Table</u> presented the Council with a check for \$2,180 to help compensate St. Peter's UCC for utility costs over the last year. Harvest Table has provided meals for over 13 years, continuing to serve 100-125 weekly.

<u>Pastor's Report</u>: Pastor Kurt reported going to two joyous events, the Men's Breakfast and Women's Fellowship Luncheon. Thanks to those who organized these special times for congregation members.

Pastor Kurt has been very, very impressed with our whole staff at St. Peter's, who he feels go above and beyond the call of duty. He thanks the Council who recognizes their abilities and has given Christmas Bonuses to staff.

Building and Grounds: Elevator: An email to inform Council about the Emergency Elevator Repair was sent on Monday, Dec. 12th. Two bids were received from Century Elevator Service. The first for Hoist Repair was \$2,866 and the second, Door Repair, for \$3,085. Because of the amount, Council needed to vote on the immediate repair of this safety issue. Council members voted by email and approved by Tuesday, Dec. 13, 2022.

Building and Grounds felt Council should give B&G more leeway on emergency issues. B&G also voted that the East Parking Lot with retaining wall should be sold and recommended that to Council.

<u>Cemetery Board</u>: Progress has been reported about the new sign for the Cemetery, the board hopes to get installed in mid-January.

The big back hoe is leaking fluids badly. This will need to be addressed by repair or replacement.

<u>Festival of Trees</u>: Over 1,200 people attended the Drive Thru Christmas Display held at Mid-American Coaches. We thank all who worked very hard on this project.

<u>Pastor Search Committee</u>: The Committee continues to work to complete our Church Profile and hopes to have this complete and ready in January.

Notes from the Treasurer:

- Finance Committee and Church Council discussed the financials and our concerns about the negative balance in the general fund. Ideas generated from discussions included:
 - Changing the current percentages on the weekly offering from 85% to general fund and 15% to the building fund to 90% to general fund and 10% to the building fund. This was approved by Church Council.
 - Creating a list of items that the congregation may be interested in underwriting such as: Bibles that are gifted to our youth (varies), annual elevator inspection (\$435), annual organ inspection (\$520) etcetera. A full list will be created and shared with the congregation in the new year.
- Both groups discussed paying off the Heritage Bank loan and save on the interest. It was discussed that with the general fund being in the negative and "borrowing" from the other funds, we may not want to lower the building fund too much. The Church Council did decide with the Finance Committee's motion to increase the loan payment from \$2,000 a month to \$3,000 a month.
- Finance Committee suggested and Church Council approved closing the Property Sale money market, earning 0.60%, and putting the funds into a 6 month CD earning 4.60%
